



## THE PRESIDENT'S PAGE

Having recently returned from the U.N. Stamp Expo at State College, I thought I would share my impressions with you. Overall, I would say I was quite impressed. On Wednesday evening after traveling all day, I attended the reception given by the APS and UNPA. It was gratifying to see the exceptional turnout of UNP members, UNPA and APS dignitaries, and members of the Pennsylvania State University administration. All the UNPA chiefs were in attendance. It was fun meeting Tony Fouracre, Rita Fernando, Riccarda Tours and Hugo Valdes. I found them all very approachable and willing to talk about the issues in U.N. philately.

The next morning, I attended the first day ceremony. The turnout was excellent, catching UNPA by surprise. They even ran out of programs and C folders before everyone had a chance to get one. By the end of the day they had run out of other philatelic items, such as the special envelope, and had to overnight more from New York before the show reopened on Friday. I spent most of the day at the UNP table meeting many collectors, selling our monographs, recruiting new members and later, along with Mark Steven Corrinet and Bernie Kosmoski, judging the exhibits.

The exhibits were very impressive, with Earl Merriman's excellent "London 1945 UN Slogan Cancellation" garnering both the UNP President's Plate and the APS Grand Award. The APS and UNP judges were in close agreement on almost all the awards! The UNP gold award was won by Stephen Cohen for his fine overview of UN Peace Keeping, the silver award went to Greg Galletti for his exhibit of League and ILO covers and the bronze to Siegfried Adler for his UNEF I exhibit. No less than four exhibits of the first UN issue were present, led by Reuben Ramkisson with an APS gold medal. Richard Powers' exhibit of UN forerunners won the UNPA grand award for an exhibit that best showed the ideals of the UN. Dick's wonderful exhibit traced the organization of the peace movement during the forerunner period of UN organization.

On Thursday afternoon, UNP held a club auction. Spirited bidding among the two dozen attendees and a strong book led to some excellent results, particularly in the first issues, once again attesting to the popularity of this area.

On Friday, strong UNPA sales continued, and UNP held its national meeting. The meeting mostly consisted of the three UNPA chiefs speaking about the 1992 issues. Rita Fernando showed sheets of the upcoming human rights issue as well as enlarged photographs of the following

issues. I truly think that 1992 will be very exciting with some outstanding issues including the spectacular spaceship earth and cultural preservation issues. Afterward, I journeyed to the APS headquarters and viewed the rarities from the Geneva Postal Museum covering the League of Nations and organizations devoted to Refugees. I would love to have a few of those covers in my collection.

The award ceremony was during lunch on Friday. I gave out the UNP awards, but missed the APS and UNPA awards as I had to catch a flight home. I sat next to the State College postmaster and found him quite interesting. He told me that his people were working overtime to get the UNPA mail into plastic wrappers so the collector prepared covers would arrive unmarred. The UN mail could only enter the US mail stream on Thursday and Friday from State College.

Overall, the trip was very enjoyable. The strong showing and long lines at the UNPA sales counter attest to the continued popularity of UN collecting. Let's hope UNPA does it again in 1995, for the fiftieth anniversary of the UN. I plan on being there and hope that everyone else can also.

### U.N. EXPO 91'

One of the highlights of my trip to Expo'91 in State College, PA, was a talk given by U.N. staff stamp designer Rocco Collari. While admittedly not a philatelist, his love of the communication medium of stamp design was readily apparent throughout the presentation. Collari's first U.N. issue was the World Heritage Set of 1984. He is the designer of the current 40th Anniversary issue in the stamp-on-stamp format. The first design of the anniversary set he wanted to highlight Ole Hamann's classic designs in an unobtrusive manner. The first proof of the new set used white stock paper which was replaced by the off-creme color stock originally used in the first issue of 1951.

Collari used examples of his original stamp artwork to illustrate his "design process" which is a method of continually refining the design concept through a series of successively more detailed sketches. While some artists are able to envision the entire design at one sitting, Collari always uses the refinement approach. Even when the design is completed there are still numerous design decisions to be made including deciding the paper stock, inks, marginal markings, perforation layout and sheet format.

Besides staff artists, U.N. issues are also designed by worldwide artists chosen either through competition or direct commission. The commission paid is strictly a

modest token for the artist's efforts. Collari stressed that all the artists contacted for commission (because their art exemplifies a given theme) have been uniformly thrilled to design stamps for the United Nations. Often it is their first stamp issue and they experience difficulty in working in such a small medium. Many works simply can't be miniaturized while still keeping their original impact. U.N. staff designers work with the outside artists throughout the design process until the final proofs are approved. Peter Max has designed an exploration of space issue for 1992 which will be rouletted (perforated by straight slits) since normal perforations interfered too much with his design. The only other U.N. issued that was rouletted was the 1967 Chagall souvenir sheet. All the design artwork remains the property of the United Nations. In the past, original artwork has become available on the market presumably via the artist or by theft from the archives.

I gained a new appreciation for all the design complexities inherent in stamp production. What I remember most from Collari's presentation was his remark that stamp design is different from all other types of commercial artwork. Decades after the stamp has been released, collectors worldwide, tongs and magnifying glass in hand, will be judging the artist's efforts.

## LETTER FROM BRITAIN

But I was defeated by flight, accommodation and customs problems. The flight problems were minor. The accommodation problems were solely related to the intervention of (wait for it!) a football match(!!) Don't take any notice of me - when anything gets in the way of any U.N. activity, I see blue! As to the (British!) customs nonsense that could have been avoided if the U.N. had extended Diplomatic Bag facilities to help foreign exhibitors (as, I understand, has been done before).

We can do little or nothing about petty flight regulations, and less about football fever. But all national philatelic societies that have anything to do with international shows should long ago have ironed out customs problems. Surely a simple deposit of photocopies of the exhibit sheets would be a perfect safeguard against customs and excise abuses? A.P.S. please copy!

I hope (I'm sure) that Expo 91' was a great success and am looking forward to our UNSG President Stan Simpson's report upon it.

Why Don't Dealers...?: (1) use soft pencils (easily erased) when marking prices on covers, etc. (and on the back and

not on the front); and (2) wrap up? They sell you items costing a small fortune and (if you're lucky) shove them in a sort of paper bag that you'd expect to get if you were buying a few biscuits ("cookies" to you). Or are they better over there?

Editor's Note: No Bill, if anything dealers are worse, they rarely provide even a paper bag.

A Reason for U.N. Successes - and Failures: In a debate (on Lebanon) in 1984, the British representative (Sir John Thompson) said that when the U.N. was allowed to operate it was effective.

Dag Hammarskjöld: When shall we see Dag on a U.N. stamp? In my book he was the greatest world leader of the second half of the 20th century - and there are a great many stamps and other philatelic items to prove that a great many people share my enthusiasm for this man above men. And if the UNPA won't (or can't) produce a stamp, what's to stop WFUNA - or the UNP, UNSG, UNOP, UN-VE (or the lot of us!) producing a special cover? How about a caricature - another from Al Hirschfeld?

P.S. Does anyone else have a separate Dag Hammarskjöld collection as I do? If so, has he/she any items to sell/trade?

Controlling the Stamp Market: I've just noticed a new issue (I won't mention the country - there are plenty of other's as bad or worse) with three values each of two (different) stamps se-tenent. There can be no postal justification for this sort of thing. The extra three stamps are only issued in order to extract even more money from stamp collectors. I'm tired of it. But where are the protests from those who are supposed to be organizing our hobby? I sincerely believe (and certainly hope) that collectors will not be prepared to bear this sort of thing much longer. In the end, countries that misuse the collectors, will find that they have killed the goose.

And - UNPA please note - it's your job (as I see it) to set a pattern for stamp producers everywhere. Or am I being unreasonable - asking too much? Let's have your opinion.

The Gulf and the U.N.: I have been looking for any philatelic item demonstrating any sort of connection between the Gulf war and the U.N. (Not UNIKOM - that came after the war). Can anyone suggest anything? Or is there a widening gulf between the war and the U.N....?

Early ILO cover: I have just purchased an ILO cover posted November 19, 1920. ILO's first headquarters were first occupied in July 1920, but this is the earliest cover that I have seen or heard of. I imagine that there must be several posted before November 19, 1920, if you know of any please let me know.

## CLAY'S UN COVER CORNER #7

With the recent advent of the Arab - Israeli Peace Conference, I thought it appropriate to write about one of the most important United Nations officials who dedicated himself to peace in that region, Count Folke Bernadotte.

Bernadotte was born in Stockholm, Sweden on January 2, 1895. He was a descendent of the royal line and a nephew of King Gustav V. After graduating from Karlberg, the Swedish national military academy, he joined the Royal Dragoon Body Guard and the Royal Horse Guard from 1918 to 1930. From 1918 to 1940, he was also active with the Sveriges Scoutforbund (Swedish Boy Scouts), and engaged in extensive business activities including representing Sweden at the 1933 Century of Progress Exposition in Chicago and was Commissioner-General at the New York World's Fair (1939-1940). On December 1, 1928, he married Estelle Manville, of New York.

When World War II began, he changed the direction of the Boy Scouts, training them in anti-aircraft defense and as medical assistants. His most important work was as Vice Chairman of the Swedish Red Cross where he supervised the exchange of German and British prisoners of war. This work brought him into close contact with high ranking officials in Berlin and London. On April 24, 1945, he was asked to come to Lubeck by Heinrich Himmler, head of the Gestapo and Commander-in-Chief of the German home front. Here Himmler offered a conditional surrender of Germany to the United States and Britain, provided Germany could continue the war against Russia. Bernadotte conveyed the Allied rejection to Himmler in Flensburg on April 27. Shortly thereafter, Himmler committed suicide and the German war effort collapsed.

Bernadotte became President of the Swedish Red Cross on January 1, 1946. On May 20, 1948, he was chosen by the United Nations Security Council to mediate the conflict between the Arabs and the Jews growing out of the partition of Palestine and the withdrawal of British troops. He initiated conferences with the respective leaders on both sides and worked extremely hard toward an equitable solution. Neither party to the controversy would make any concession and fighting continued with little interruption, in spite of a "cease fire" order on June 2 and the attempt at imposing penalties on the combatants. He did manage to obtain a four week cease fire on June 11 and on June 28 he submitted a peace plan to the Arab League and the Israeli government which both sides rejected in part. On July 12, he made a report to the United Nations Security Council in session in New York and then returned to Palestine.

On September 17, Count Folke Bernadotte and Colonel

Andre P. Serot of the French air force were assassinated in Jerusalem by Stern, an organization of Zionist extremists led by Jacob Cohen. Stern committed numerous acts of terrorism against Arab and British personnel. Three days later, his completed report on his peace efforts was published in Paris. His terms of peace, to be imposed by the United Nations, won wide support by the United States and British governments.

Ralph J. Bunche, the personal representative of United Nations Secretary Trygve Lie and assistant to Count Bernadotte succeeded him as Palestine Mediator, serving until August 11, 1948. On September 18, 1949 a memorial service was held in Jerusalem. Trygve Lie spoke:

"Two days ago a memorial plaque was unveiled at Lake Success in honor of Count Folke Bernadotte. It is fitting that the anniversary of the death of the United Nations Mediator should also be commemorated in Jerusalem, where he lost his life.

Let us mediate on the sacrifice of a great man whose mission was a mission of peace. He fulfilled it in a spirit of impartiality, equanimity and love for his fellow-man.

Dr. Ralph Bunche, who took up the torch when it fell from the Mediator's hands, has aptly said that it was Count Bernadotte who first led the warring parties on Palestine to the road to peace.

We shall honor his memory today by resolving to continue to work in his spirit for the conciliation of outstanding conflicts and for peace in this Holy City and in the Holy Land."




Figure 1: A 1946 cover from Jacob Cohen to his family in Kfar Sava, Palestine. Cohen was located at this time in a British internment camp at Asmara, Eritrea.




Figure 2: From Andrew Cordier to Bernadotte in March, 1948. Note that he seemed to have already assumed the title of U.N. Mediator prior to the Security Council appointment of May 20.




Figure 3: Cover from Bernadotte to Trygve Lie the day before the Security Council's cease fire order,





Figure 4: Thank you note and cover from Estelle Bernadotte express gratitude for expression of sympathy after the death of her husband.

Also a special green cachet, shown in Figure 8, was used in official mail from the conference.



# UNTEA CORNER (Domestic Parcel Post)

The bulk of this discussion is taken from data of the period of Dutch administration of West New Guinea, firstly (and frankly) because I have no UNTEA data, and secondly because UNTEA for the most part continued the Dutch system, with the odd modification.

From 1956 to 1959 a total of 11,100 domestic parcels were handled by the postal service. I have no data for 1960 - 1963, but it appears that the numbers were small regardless. A medium size US city would handle a similar volume in a few weeks or less, especially around Christmas time.

Anytime a parcel was presented at the post office, the sender had to complete an address card (fig. 1, 2). The postal clerk had at his disposal a register consisting of numbered paper slips. Each strip was subdivided in 3 portions, all with the post office's name (printed or cancelled) and the same number, separated from one another by lines of perforations. Part 1 remained in the register, and on this the clerk noted some data such as

weight, etc. The 2 other parts, one large, one smaller were removed from the register. The larger piece was affixed to the parcel, the smaller to the address card. No receipt was given to the sender. If he wanted one, he had to fill in another form and pay an additional fee.

Address cards were usually transported in the same dispatch as the parcels. When large numbers of surface mail parcels were shipped, however, the cards were often sent by air. (This was the practice for foreign parcels, and alerted the Notification of arriving parcels were then mailed to addresses with the request to pick up at the local PO at specified dates and times.

Address cards of delivered parcels were retained by the post office and stored at headquarters in Hollandia for the duration of the claim period, i.e. the year the parcel was accepted plus 2 subsequent calendar years. Thereafter, the stamps were cut out and sold with others. The remainder was destroyed. Obviously, some used address cards have survived, intact.
