





UN STAMPS IN AUSTRIAN DENOMINATIONS IN 1979?







When our friend Mike Konnick wrote in his newsletter about a year ago that he "can't help but continue to stress that Vienna soon will become another major stamp center for UN philately," he probably did not realise how close this was to becoming a reality. However, by the end of last year, German and Swiss philatelic magazines published items that the Austrian Government would welcome the issuance of UN stamps in Austrian schilling denominations -- and that the UNPA was beginning to think about such a project.

By February of this year, matters already were beginning to come into focus. The philatelic press has noted that a Postal Agreement was in preparation (similar to those between the UNPA

and the USA and Switzerland. UN stamps in Austrian schillings could be issued as early as 1979, possibly beginning with an issue coinciding with the opening of the new UN center in Vienna.

The fact is that two UN specialized agencies- UNIDO (the United Nations Industrial Development Organization) and IAFA (the International Atomic Energy Agency) already are located in Vienna. Their 2600 UN employees will move into the brand new "UN City" beginning this Fall, along with those of smaller agencies and commissions presently located in Geneva and New York. Vienna wants to be the third UN center. When one recalls that the current UN Secretary-General is an Austrian and a philatelist, my personal opinion is that the chances are great for UN Austrian issues.

For quite some time, there have appeared regularly on the UN market stamps bearing a purple, rubber stamped legend "SPECIMEN", which have been represented to be specimen stamps of the printer, Thomas DeLaRue and Company, Limited. These "specimen" appear for a number of issues, including C1-4, 26-29 and 60-63. They are listed in Lindner's, with a notation that they probably are forgeries. In many instances, they are accompanied by "letters of authenticity" such as the one reproduced below.

However, it now is clear that these stamps indeed are not genuine specimen of Thomas DeLaRue. It appears that the letter is correct as far as it goes— the rubber stamp was an official specimen impression of Thomas DeLaRue. The signer of the letter was a director of Thomas DeLaRue, although one leaving the firm at the date of the letter. It is reported that, shortly thereafter, a number of sheets of DeLaRue UN issues were sold bearing this rubber stamped overprint. THIS OVERPRINT NEVER WAS APPLIED TO ANY UN ISSUE BY THOMAS DELARUE. The overprint was applied privately by someone who had possession of the genuine rubber stamp, or a good reproduction of it.

While this information has been around for a number of years, and knowledgeable UN specialists generally have shunned these overprints as the forgeries they are, confirmation of these facts, even obliquely, has appeared only recently. Genuine proofs of DeLaRue issues have been observed, including proofs for some of the issues overprinted "SPECIMEN" (C1-4 and 29-30). These are singles cut from imperforate sheets and pasted on card. (Later genuine DeLaRue proofs are die sunk directly on card.) It is not known precisely how many such proofs exist, or are on the market. Only one of each has been observed. However, their existence is further confirmation of the true nature of the forged specimen. [The DeLaRue specimen will be the subject of a fully illustrated article in a later issue of the Journal.]

As a final note, it is believed that the fully imperforate examples of Cl-4 which are on the market are those which were used to make the card die proofs. The authors have observed the 15g airmail imperf (C3), and has proofs of Cl, C2 and C3 available for comparison. Anyone possessing imperforate examples of Cl-3 is invited to communicate with the authors c/o this Journal to arrange, if possible, for a direct comparison of the proofs with the unmounted imperforates.

- Q: What is the difference between the Geneva UN circular cancels "with stars" and "without stars"?
- A: The cancelling devices "with stars" are used by the UN Postal Administration, and are applied to all philatelic mail, and items deposited by visitors to the Palais des Nations, Geneva. This is true for both the circular hand cancels, and the machine slogan cancellors. Cancels "without stars" are those used by the UN post office only for official mail of the UN or mail deposited by UN personnel in post boxes in non-public areas.
- Q: What is the significance of the letters seen on UN/Geneva hand cancels?
- A: Each hand cancel has a letter, and each letter cancel is assigned to a particular clerk. If that clerk is not on duty, the cancel is not used. The purpose of these letters (which is standard Swiss practice) is to control the use of the cancelling device and provide a means of tracing improper usage.
- Q: Can I obtain Geneva first day covers with slogan cancels, hand cancels, or "no star" cancels?
- A: "No star" cancels- no, since the UNPO gets UNPA emissions only for use after the philatelic first day. The others may be obtained through an agent or dealer who is present on the first day. These cancels are available if registration is requested, or stamps other than the new emission are on cover.

AUSTRIAN SPECIAL CANCELLATIONS FOR MEETINGS OF THE UNITED NATIONS AND UNITED NATIONS AGENCIES

Austria has been a popular location for meetings of the United Nations and its agencies, probably ranking third after the United States and Switzerland. Most of these meetings in Austria have been held in Vienna, where an increasing number of UN offices are being located. Vienna has been the headquarters of the International Atomic Energy Agency (IAEA) since its founding in 1957, and of the United Nations Industrial Development Organization (UNIDO), since its start in 1967. Next year, a new UN complex is scheduled to open, which will put Vienna on a footing with New York and Geneva.

A fascinating subject is the postal history of these Vienna meetings. This would include special meters, cancellations, registry labels, and receiving markings for conference mail, and might also be deemed to include conference corner cards, and official conference imprints and cachets. This article describes only special cancellations.

The writer has identified 23 different Austrian meeting cancels used between 1957 and 1973. They are listed below, in chronological order. Typically, a number of cancelling devices were used for each type, and each is identifiable by number. All cancel numbers observed by the author are listed. Where known, the conference dates also are listed, along with the earliest and latest observed dates of cancel use.





The writer would welcome correspondence on this subject from UNP readers, addressed c/o this <u>Journal</u>. Especially welcome would be information on UN conference cancels not included in this listing, and on additional cancel numbers and dates observed.

A final interesting question is why no meeting cancels have been seen for the last four years. IAEA General Conferences were held in Tokyo in 1965, in Mexico City in 1972, and in Brazil in 1976, with all three meetings honored by stamps issued by the host countries. IAEA Conferences apparently were held in Vienna in other years, but no special cancel has been observed since 1966.

THE TIFFANY COVER

Over thirteen years ago, on a shopping spree at Tiffany's on Fifth Avenue in New York City, an architect bought several beautiful miniatures. Items at the posh Tiffany store usually are expensive, but this bargain purchase totalled only 40 cents! It was 10:05am, December 7, 1964, and the items bought were six new United Nations stamps. The purchaser was given two embossed Tiffany envelopes free, as part of a promotion for the release of the "Education for Progress"set.

The idea of a simultaneous sale of stamps at the "House of Diamonds" (Tiffany's) and the "House of Glass" (UN Headquarters) originated with radio correspondent Moses Schonfield, a UN philatelist and friend of Walter Hoving, Board Chairman of Tiffany's. A life-long interest in education prompted Mr. Hoving to make the arrangements with the United Nations Postal Administration chief, D.T. Clements, under which Tiffany's joined in the first day sale. A special sales counter was given to the UNPA at Tiffany's, Tiffany's prepared the engraved cachet (see cover photo), and provided one of its windows for a UNPA exhibit. Because of the restrictions of the US/UN postal agreement, no cancellations could be made at Tiffany's, but couriers took the stamped envelopes deposited there back to UN Headquarters for cancellation and dispatch.

To coincide with the "Education for Progress" issue, New York City Mayor Robert F. Wagner proclaimed the week of December 6 as "United Nations Stamp Collecting Week." The Fifth Avenue Association joined in the salute by having its member stores display UNPA posters. The Enthusiasm spread to the Real Estate Board of New York, which agreed to display UNPA posters in elevators in buildings its members managed and owned throughout the city.

Tiffany's produced 1000 5 3/4" by 3 5/8" embossed envelopes. In the upper left corner appears the legend:

Tiffany & Co. Fifth Avenue & 57th St. New York 10022

At the bottom left is engraved a small UN emblem and the words, "First Day of Issue", in the same soft gray color. These cachets were given away on a limited basis with the purchase of the stamps. Two UNPA employees worked the counter at Tiffany's. UNP member Herb Conway, who was present, reported that sales at midday appeared slow.

Some collectors took their covers back to UN Headquarters to be cancelled on a handback basis- thus obtaining unaddressed first day covers on the Tiffany cachet. It is unknown just how many envelopes actually were distributed, addressed or cancelled, and how many remain in mint condition. It appears that many were addressed, and that the 5¢ single on cover is the most prevalent variety.

I would like to begin to answer some of these questions by creating a "Tiffany-Registry" under UNP auspices. If you would like to register your cover or covers, you may do so by writing to

me, c/o the <u>Journal</u>, and sending a photocopy of the face of the cover. All names will be kept confidential. Any other information about the "Tiffany enigma" also would be appreciated.

[UNP member Barbara Frankel reports that, on December 7, 1964, she was at UN Headquarters when the leftover Tiffany covers were returned to the UNPA. It appeared that approximately half of a box was returned, unusued. Since each box contained 500 covers, this would mean that approximately 250 never were sold, and that the total issue thus amounted to only about 750.]

For UN collectors, INTERPEX '78 at the New York Hilton, March 31 - April 2, was a coming of age- a major stamp show with its dominant theme, in fact, the United Nations.

On Friday, the show's major events were the opening ceremonies, with special guests Congressman Lester Wolff (of the US Delegation to the UN) and Gisela Grunewald of the UNPA. The ceremony was well attended by UNP members and officers, with all in attendance receiving ASDA souvenir programs containing a first day cancelled 13¢ Smallpox issue stamp.

Later in the day, at UN Headquarters, several UNP members were invited to the UNPA/WFUNA luncheon in honor of the new Smallpox issue. Honored guests were doctors from the WHO Liaison office in New York and the Global Eradication of Smallpox Program, and Liam Roberts, designer of the WFUNA cachet for the issue, who were among those receiving large blue presentation folders from UNPA Chief Ole Hamann. In his comments to the luncheon, Mr. Hamann was generous in his praise and mention of UNP.

Throughout the show, crowds were large around dealers with UN material, and around the UNP booth. Special thanks are due to Isidore Kusminsky, Herb Bauer, Pearl Borah and Marcia Galletti for their hours of attention to UNP's booth, and the new members signed up.

Saturday morning saw meetings of the UNP Board of Directors and of the membership. All UNP directors were in attendance, as well as some 25 other UNP members from across the US and Canada. Among the more noteworthy decisions made at these meetings:

--An offer from Midaphil in Kansas City to host the second UNP convention in September/October 1979 was accepted. It was decided that, whenever the UNP convention was held in the Fall, there also would be a Spring membership meeting. Next year it will be at Compex, and in 1980 at INTERPEX. Every year it is planned to have a major UN exhibition of at least 100 frames at INTERPEX, so that it becomes known as "the UN show".

--Creation of military and imprint study units was confirmed, and the application by UNEET to be the imprint study unit was accepted unanimously by the Board. President Knoeckel also was encouraged to ascertain whether interest existed for other such study units, and to arrange for their creation.

--Reportsalso were received on future publications plans, and on the incorporation of UNP, which was voted at the initial meeting of UNP at Compex '77 and now is in progress.

Another highlight of the show was the UNP Awards luncheon held on Saturday at the Keewah Yen restaurant. Guests of Honor were Ole Hamann and his wife, and Gisela Grunewald. In addition

to a magnificant banquet, the 55 UNP members present were treated to presentation folders honoring the Smallpox issue. Mr. Hamann made a brief speech, presented large blue "dignitary" folders to UNP officers, this Journal's editor, and Greg Galletti. Special presentations were made to Mr. Hamann of his UNP Honorary membership card, and a UNP President's Award plate (No. 1). Mrs. Hamann and Ms. Grunewald were presented with UNP medals.

A special Turtle Bay Philatelic Society award was given to Marcia Galletti for her hours of service in organizing the UNP exhibits at INTERPEX. UNOP, the European UN collectors' club, sent a special award to be given to the youngest UN exhibitor, which was given to Greg Galletti.

On Sunday, the UNP activities concluded with a slide/lecture by Herb Conway about the variety of UN stamps, and guided tours of the exhibits by the judges and some exhibitors. MAYER ON METERS:

DATE VARIETIES ON UN METER STAMPS (IV) BY JACK MAYER

Though proof is not presently available, it is believed that another month error may exist within the slogan use "International Law Commission, 1949 - 1974". A PB#3 impression dated JUN 15'74 (Saturday) may actually have been JUL 15'74 (Monday). This judgment is based on the delay in acquisition of this item along with the fact that no impressions have been noted on the latter JUL 15'74 date for PB#3. Verification might come if one had access to the UNPO records for JUN 15'74 and if those records showed that this machine was not used on that Saturday date.

A similar error also is noted with the slogan "To Reaffirm Faith In Fundamental Human Rights" (see Figure 29, below). This slogan was in use only from October 24, 1968 to December 9, 1968, less than two months. Careful examination of the dies with dates of October 29 and November 29 seem to indicate that the "JAN 29'68" impression below should have been "NOV 29'68" and that this error was corrected during the day to reflect the proper month. There also remains the possibility that the day numeral also was incorrect, in which case no verification of actual use is available to us.




Figure 30 - NOV 24 with slogan

One of the most interesting month errors occurred with the early use of the "Peaceful Uses of Outer Space for the Benefit of Mankind" slogan. Though this slogan had its first day of use on September 25, 1972 (CTO covers), it was not seen commercially until September 27. The meters were used without slogans for the first two days. On PB#2, the slogan deteriorated so badly that on October 25th it had to be removed from the meter and "no slogan" impressions made from that point on. The final two days of that slogan (OCT 23'72 and OCT 24'72) were printed only as NOV 23'72 and NOV 24'72. Interestingly, November 23 was Thanksgiving Day, a postal holiday, and the 24th was a day with normal, "no slogan" use. Figures 30 and 31, below, show correct and incorrect dates for November 24, 1972.

As in both the day and year portions of the dater, the month also can be misset, as in the example of APR -3'73 in Figure 32, below.

On at least two occasions, the dater was set and the resulting date crossed out with no correction made. Both printed dates were Sundays.






Figure 33 - MAY 10'70 PB#3 (cutout)

It is possible that both of these Sunday dates, as shown in Figures 33 and 34 above, should have been Mondays.

In 1968, two interesting errors occurred. These are first days of slogan errors in that the date was set one day prior to the official first day of slogan use. This may have resulted by the slogan having been changed just prior to the close of the preceding day, or the date not having been changed immediately upon commencement of the actual first day.

Perhaps the most startling date error was made in 1967 when the slogan, "United Nations Official Mail" was in use between October 30 and December 29, 1967. Not only was the error slogan inverted, but the dater was set so that possibly the only correct part (and even that is questionable) was the actual day. See Figure 37 on the next page.

No doubt varieties similar to the foregoing will surface continually. The challenge is there to try to determine just what happened at any given time. The list is not necessarily complete, and if any collector has any meter varieties that should be recorded, do let me hear from you.

OPEN YOUR EYES, UN SHOW JUDGES AND EXHIBITORS

BY MIKE KONNICK

There can be no doubt that there is an upsurge of interest in United Nations stamps. Recent price rises speak for themselves, both in mint issues and odd issues, like the Brussels Fair and UNITEA sets.

Literature about all aspects of UN philately is more abundant than ever before. Contributions in many areas- such as military mail and meters- have come from non-UN collectors. In general, what has happened is that an increasing number of collectors have begun to use UN stamps as a sideline to their normal collecting interests, and in a manner that they soon seek specialization.

This brings me to my point: how to get our fellow UN collectors to exhibit. One doesn't have to be a super specialist to exhibit. Every exhibit, whether it's the collector's first or fourteenth, should be judged by fair standards. The only exhibits to receive awards should not belong to specialists of ten year's standing who have been exhibiting for five years. Certainly there are many other exhibits that can and should be considered.

If three awards are slated to be given in a UN category at a show, in my opinion those three awards should be given. The strategy behind giving awards should be to encourage all UN collectors, regardless of their degree of specialization, to exhibit. Certainly, before the top UN exhibitors of today reached their current plateau, they put in much work and overcame many problems with their presentations.

It is a responsibility of judges to go over each exhibit with the exhibitor. The judge's critique, in sensible language, should help the exhibitor see areas in which improvement is required- perhaps more research, a better writeup, or a different arrangement of material. If general category judges do not understand the caliber of the exhibit, a UNP accredited judge should be present to assist. Possibly, the UNP accredited "judge" could be present just to describe the material exhibited, explaining areas outside of the average judge's competence. After all, judges should be willing to learn something from their duties. If an exhibit is from out of town, a critique (honest and tempered) should be included when the exhibit is returned to its owner.

They live in communities which in many instances are isolated from other UN collectors. In addition to putting out this Journal, and funding specialized studies, UNP and other organizations must devote attention to encouraging new exhibits and exhibitors. Every UNP member should exhibit, for each time he does, he flies the UN flag at the show. It's a warning that UN philately must be taken seriously and deserves its proper place in major exhibitions, nationally and internationally. It states that UN is worth collecting for the same reasons other countries are worth collecting. And, UN is a most diverse field.

Most importantly, stamp show judges should and must lean away from the idea that hampers all modern philately-that something must be old to be good. Instead of nineteenth century, I mean by "old", in the UN sense, 1-11, League of Nations, or

UPU exhibits. Other areas also are worthy of awards. Classic material should be in a special category so as not to deprive modern UN of a fair share of the limelight.

Attending Internaba '74, I noticed two UN exhibits. They did not demonstrate sophisticated knowledge, and in fact contained some glaring misinformation (and one was written in ball point pen). Yet, one won an award. UN Geneva has gone far to encourage UN collecting in Europe. Eileen Maisannes broke the ice in 1975 at Espana. The Rademwormwald show in 1976 brought a full exhibition of UN material. Show awards were even given for UN literature.

Over the last four years, the entire picture of UN philately internationally has changed. In Europe, UN rapidly has gained respect as an area worthy of collection. In the US, much work remains to be done. And the responsibility rests not only with UN clubs, and UNPA, but with stamp show judges. New collectors should be given every encouragement. The second time they exhibit will be better than the first. And, if judges see the diversity of collecting habits that are United Nations, we can quickly call their attention to creating new, special categories for UN areas.

In my opinion, UN judges have a bigger responsibility to look with favor upon any and all UN exhibits. Parochial attitudes towards beginners can only harm the hobby, and leave the goal of creating more serious and knowledgeable UN specialists unaccomplished.

Post-1951 Definitives: Over the years, the 1951 definitive series has received much attention, including exhaustive study by Ray Goodey and others. The various printings, papers, and cutouts of this popular series have made such a study not only possible, but also necessary. But what about the definitives issued since that first series? A number of people agree that a study should be done on them as well. UNP member Duane Lamers would like to initiate such a study, or contribute to one already in progress. He is interested in exchanging or corresponding about these definitives, and believes that holdings of material with known purchase dates, or "first day of service" covers, might hold the key to success of such a project. More on llg definitive reprint: Duane Lamers also writes that the easiest way to identify the llg definitive reprint released in December 1977 is by the brighter, shinier gold of the UN emblem. The light blue background, he reports, is not necessarily heavier. Under uv light, the paper of the second printing is brighter.

LEMANEX '78: J.L. Emmenegger reports that the Swiss National Philatelic Exhibition, LEMANEX '78, will take place in Lausanne between May 26 and June 4, 1978. UNPA/Geneva already has announced that there will be a show cachet. Mr. Emmenegger reports that a special cancel (as at INTERNABA '74 in Basel) also might be used. The exhibition catalog is available from LEMANEX, P.O. Box 598, CH-1001, Lausanne, Switzerland at Pr.Sw.4,00 each, plus postage.

25¢ Definitive Variety?: Member Walter Yovdoshuk inquires about an item he has in his collection- Scott \$9, with a dark blue, irregular dot, approximately lmm from the inside border, to the left and slightly above the letter "U" in the word "UNIDAS". The dot clearly is visible on both sides of the stamp. Any reader who can identify this as a freak flyspeck or constant variety is invited to write to the Editor.



TREASURES OF UN-GENEVA: Postal operations continue on a FD of issue, the UNPA and the UNPO clerk's use their regular round letter cancels and the machines. UNPA cancels contain stars; the UNPO

cancels read "1211 Geneve 10", see illustrations above. The "regular" cancellations cannot be obtained by mail. The UNPO is a "working" post office and does not accept the new stamps for postage until one "working" day after the FD; thus UN-G issues actually have two first days. One, the UNPA FD and then the UNPO FD.

Lindner does not list these cancels on fdc's, yet it does list them on Souvenir Cards; by the time Lindner and other specialized catalogs get around to listing them the prices will be much higher or the items will not be available at all. Take a tip from us, these will be the TREASURES of UN-GENEVA.
